Several States conduct telephone interviews prior to the final decision to help prevent potential fraud in unemployment insurance. These state agencies give people access to job advertisements and vocational training resources, and registration is mandatory to receive unemployment insurance benefits. If you are having trouble locating your local center, contact the state unemployment agency for assistance. While you can breathe a first sigh of relief once your initial application is processed, make sure you maintain your eligibility status by continuing your job search as directed.Step 6: File Your Weekly Claim and Continue Your Job SearchOnce you start receiving your unemployment benefit, you need to submit your weekly or bi-weekly claims (varies by state) online to be paid â without exceptions. You will be asked to answer some questions about any work done each week and any other income received. If you fail to file your weekly claim, your benefits may be delayed or discontinued altogether.
